Margie motioned to approve a budget of \$300 to place an ad in the Horsetrader and other needs. Anne 2<sup>nd</sup>, motion approved. Major sponsors were suggested to help pay for KFROG to attend and publicize the event. Marcia will contact the John Deere Company and Auto dealers were also suggested. A collage of photos from last year's event was also suggested for promotion.
